




What Does "Non-Fungible" Mean?

Non-fungible means the asset is irreplaceable. All NFTs created on the blockchain are unique and have a single owner.

NFTs Explained

NFT is a short form for Non-Fungible Tokens. NFTs are digital assets embodied as Artwork, Videos, Music, GIFs, or Memes traded on the Blockchain network.

Unpopular Notion Behind NFTs

NFTs make it possible for artists to integrate their identity into the art. Creators and collectors use the "metadata" data recorded on NFTs to confirm and authenticate ownership rights. NFTs listing ensues on a marketplace like NFA.space after minting.



...More Details On NFTs

- NFT Marketplaces detects and reduces art forgery
- The visibility from NFT marketplaces grants artists the opportunity to network with high-profile investors
- "Minting" refers to converting a digital item into an NFT (Artwork, Music, Video) which is stored as Blockchain data
- Every NFT includes a royalty program. This allows the artist to earn a percentage of each sale



Setbacks in the Art Industry

The Art industry has potential, but it also faces obstacles like market manipulation, provenance disputes, ownership and forgeries.

Traditional painters deal with the difficulties of selling their work through galleries, receiving little earnings, and having their pieces damaged physically. They are unfamiliar with the requirements to wield NFTs to their best advantage.

...What's More

The NFT market's emphasis on digital art trading further discourages traditional artists from participating.

To address these issues, an NFT project named "NFA.space" was developed to utilize Blockchain technology in bridging the gap between physical and digital art.


What is NFA.space?




Current Trend in the Art Market

Today, several galleries and auction houses utilize the Internet to market to a global audience. Technology advancements have increased art sales online more than they have increased sales of artwork in physical galleries.

The transition from offline to online art networking is producing art diversity. Today, Artists are discovering creative strategies by incorporating NFT technology to raise the value of their creations.

Companies such as Nike have developed new NFT trading platforms for their clients. Nike launched Swoosh, a platform where customers can exchange digital versions of their apparel. Nike currently earns from the sales of both its digital and tangible goods.






The Collection house project, whose task is to use NFT as a tool to:

Problem and ...

Currently, the pattern for transferring copyrights to the NFT and Blockchain environment is viewed as a unique opportunity to perpetuate them, ensure swift payment of copyright royalties, minimize art fraud, and provide virtually equal competition as for all creators so for all owners.

The rapidly developing technology of applying NFT to physical objects is promising (Phygital).

Combining physical assets with NFTs helps make the process of ownership confirmation a digital value.

Additionally, the use of a physical art object photo as an NFT allows viewers to enjoy its visual perception and digital format.

Benefits of NFTs In The Art Sector

• Easy monetization of digital artworks. The fashion brand Nike, earlier mentioned, sells its digital items without additional costs on delivery, failed transactions, or physical damage to its luxurious products.

• NFT artists earn more by selling directly to NFT collectors rather than through commissioned galleries or auction houses.

• Royalties are programmed into smart contracts to enable artists to receive a percentage of every art sale.

• NFA.space incorporates Blockchain technology to spearhead the converting and minting of tangible art into Non-Fungible Tokens (NFTs).





Market


Vision: Preservation of intellectual property and authenticity of works of art through the latest technologies to bring world art to a new stage of development.




Applying Blockchain technology:

We will also launch physical activities for all art enthusiasts!




Production

Sale Preparation

We create, deliver, and provide legal support, and portfolio for our artist NFT collection. Lastly, we will equip the artist on the steps to auction his/her artwork.

Highlights on NFA.space Production Strategy:

- initial evaluation of a piece of art,
- receipt of physical art for safekeeping,
- creation of the author's story in the project portfolio,
- creation of history and legend around art,
- creation of additional activities and performances,
- collection of information for promotional purposes,
- determination of the layout of the auction,
- project management of NFT collections.

Transportation of art is a special facet of art

Logistics using Blockchain and NFT technologies will ensure transparency, validity, efficiency, and reliability of delivery.

The receipt of the painting is documented ahead of the sale.

Next, the NFA.space team:

- Organize the movement and storage of expensive objects in the Free Customs Zones (FreePorts)
- Directs a smooth transfer of ownership
- provide safe delivery and storage of artworks in galleries and exhibitions

Insurance

We will provide insurance services for both art objects and NFTs at all stages of creation, NFT listing, and after the first sale.

NFA.space will provide artists with insurance during the movement of the painting to an exhibition, event, or museum.






Competitors

- Currently, there are no direct competitors.






